

BROUGHTON TOWN COUNCIL

Minutes of Extra-ordinary Meeting of the Full Council held on Monday, 10th June 2019, at 7.30 pm, in the Phil Grundy Community & Sports Centre, Scawby Road, Broughton

Public Participation

Two members of the public were present and neither expressed a wish to address the Council.

2947. Record of Members Present

The following Councillors were present: Councillors Senior (Mayor), Glover, Mumby-Croft, Price, Ross, Simpson & Whittingham.

2948. Apologies and Reasons for Absence

Apologies were received from Councillors Portess - on holiday, and Councillor Leitch - ill.

2949. Declarations of Interest

- (i) Councillors Glover and Mumby-Croft both declared a personal and prejudicial interest in Item 5 - Planning, whilst Councillor Simpson also declared a personal and prejudicial interest in Item 6 - Multi-User Games Area.
- (ii) The Clerk had received and granted no dispensations.

2950. Telecommunications Mast

The Council had been approached by Clarke Telecom on behalf of their client to erect a telecommunications mast at the Phil Grundy Community & Sports Centre.

Initially they had offered an annual payment along with a payment towards legal fees and valuation fees, and this was then increased by a one-off payment subject to the signing of an agreement by 29th March 2019 and valid planning consent.

The Council declined the offer but has now received correspondence from the company stating that if they do not hear details of the town council's chosen valuer then the matter will need to be referred to the Lands Tribunal, and they provide a link to a recent case taken to the Lands Tribunal between EE Limited and Hutchinson 3G UK Limited and The Mayor and Burgesses of the London Borough of Islington.

It was resolved that the Clerk should seek legal advice and also arrange a meeting onsite with the company to further discuss the telecommunications mast.

It was resolved that the information be noted.

2952. Multi-User Games Area

1. Noise - The Mayor reported that the survey on the ground conditions had come back showing no problems, however the sound reports had shown the close proximity of the houses which could lead to the noise levels causing a problem for residents near the MUGA.

There were 2 options to combat this issue:-

- a) The entire site to be secured and locked every evening.
- b) An acoustic barrier be erected at the side of the MUGA along with hedging to be planted to make it look good.

It was resolved that an acoustic barrier should be erected along with a hedge.

2. **Opening Hours** - The opening hours of the MUGA were discussed.

It was resolved that the opening hours of the MUGA should be as follows:-

Sat	9am - 5pm
Sun	10am - 4pm

3. **Activities** - The different types of activities that could take place at the MUGA were discussed.

It was resolved that in terms of activities the following be included:

Archery, Cricket, Football, Hockey, Netball, Rugby and Tennis - subject to it being accepted and if not it could be amended by the Mayor & Deputy Mayor.

Note: Councillor Simpson had earlier declared an interest in this item and therefore left the meeting whilst it was discussed.

2953. Remembrance Parade

The Deputy Mayor explained the arrangements for the Remembrance Parade, especially to do with temporary road closure, the band and a bugler. She said the quote from Shift Traffic Events Ltd for traffic management was the same as last year, and she will find out whether or not the Council will need to provide the poppy wreaths, and she had also booked the band. **It was resolved that the Council should accept the quote of £250 + VAT from Shift Traffic Events Limited for traffic management and also agree to the cost of a band and a bugler, and the Clerk should sign and send off the paperwork for the temporary road closure on Remembrance Day.**

2954. Closure of Council Meeting

The meeting was closed by the Mayor at 8.34 pm.
